Joint Powers Agreement Amendment	Moved by Director Griffiths and seconded by Director Pecsi to approve and adopt Resolution 2017-04 amending the ESTA Joint Powers Agreement extending the provision through December 31, 2018 which permits member entities to fill one of the two positions on the ESTA Board with a member of the public at large rather than a member of the governing body. Motion carried 6-0 with Directors Sauser and Gardner absent.
Fiscal Year 2017/18 Budget	Moved by Director Pesci and seconded by Director Stapp to approve the proposed FY 2017/18 Operating and Capital budget. Motion carried 5-0 with Directors Sauser, Gardner and Tillemans absent.
Board Member Reports	Director Stapp reported that motocross begins in Mammoth this weekend. Director Hoff reported that the public is interested in addressing issues of the discontinuation of the Gray Line.

Executive Director Report

Mr. Helm reported that the Mammoth Half Marathon is this weekend and that ESTA will be providing transportation. Bishop Creek Route begins tomorrow. The last day the Mammoth Old Limited Route will run is June 23<sup>rd</sup>. Funding for the June Lake Shuttle is in place and will begin July 1.
